EMA Director: Eric Johnson, EMA Director, told the commission that he had met with the District Directors on Thursday in New Brockton where he was able to meet several directors, State Emergency Management Director and Tallahassee Weather Center. He stated that he had gone to each of city offices and made himself familiar with the mayors and clerks

Chairman Seay: Commissioner Brannon stated that Chairman Seay was in Montgomery today presenting the Veterans Nursing Home and would update when he returned.

The cities are required to submit there projects no later than today for Hazardous Mitigation Grant.

Commissioner Wilks: Spring Creek Road residents have questioned getting their road paved. Discussed the issues involved with the getting right of ways and the cost to the citizens which could amount up to \$600,000. Lime rock is another option.

Commissioner Wilks made a motion to abolish and rescind the preparation for road construction resolution. Commissioner Spivey made a motion to second. Vote was 3-0.


Commissioner Hammer: Nothing to report.


Commissioner Brannon: Reported for Chairman

Commissioner Hammer made the motion to adjourn. Commissioner Wilks seconded the motion. Vote was 3-0.


