THERE WILL BE A \$25.00 SERVICE CHARGE ON ALL RETURNED CHECKS. THE UNDERSIGNED IS TO BE RESPONSIBLE FOR THE GARBAGE CAN. IF CAN IS LOST, STOLEN OR DAMAGED IN ANY WAY, THE UNDERSIGNED WILL BE BILLED FOR THE COST OF THE GARBAGE CAN. GARBAGE CANS MUST BE RETURNED TO THE COURTHOUSE IF THE UNDERSIGNED RELOCATES OUTSIDE OF GENEVA COUNTY.

(You may pay by cash, check, money order, or credit/debit card.)

IF YOUR ACCOUNT IS 90 DAYS PAST DUE, THIS IS CONSIDERED FAILURE TO COMPLY WITH THE SOLID WASTE COLLECTION AND DISPOSAL LAW AND WILL NECESSITATE LEGAL ACTION AS PROVIDED BY THE LAW, INCLUDING CHARGING THE PERSON IN VIOLATION WITH A CRIMINAL MISDEMEANOR.

The Alabama Law (AL Code 22-27-1, et seq.) that establishes mandatory services and participation in the Collection of solid waste or garbage by Geneva County, provides that every person, household, business, Industry or property owner is liable for the monthly or annual fee for the solid waste or garbage collection service made available.

AGREEMENT TO PAY: The undersigned accepts the fee charged as a lawful debt and promises to pay said fee including the cost of collection, reasonable attorney fees, and court costs if such be necessary, waiving now and forever the right to claim exemption under the constitution and laws of the State of Alabama, or any other state.

RE: GARBAGE COLLECTION

The following is a list of mandatory Rules & Regulations pertaining to garbage collection:

1. ALWAYS HAVE CONTAINER TO ROADSIDE NO LATER THAN 5:00 A.M. or PUT OUT THE NIGHT BEFORE YOUR PICK-UP DAY. DUE TO UNFORSEEN CONDITIONS PICK UP TIMES & DAYS CAN VARY; WE DO NOT GUARANTEE A SPECIFIC PICK UP TIME.
2. PLACE YOUR CONTAINER 10 TO 12 FEET FROM THE MAIN ROADSIDE.
3. ONLY GENEVA COUNTY CONTAINERS WILL BE DUMPED. NO EXTRA CONTAINERS OR BAGS OF GARBAGE BESIDE THE CONTAINER WILL BE COLLECTED.
4. ALL GARBAGE MUST BE PROPERLY BAGGED. ONLY HOUSEHOLD GARBAGE WILL BE COLLECTED. NO TIRES, BATTERIES, FURNITURE, HAZARDOUS MATERIAL, WOOD, BRICK, CONCRETE, YARD WASTE, ETC. ALL SYRINGES NEED TO BE IN A PROPER CONTAINER. DO NOT PUT INTO CAN LOOSE!
5. GENEVA COUNTY SOLID WASTE WILL OBSERVE THE FOLLOWING HOLIDAYS: New Year's Day; Memorial Day; 4th of July; Labor Day; Veterans' Day; Thanksgiving Day; & Christmas Day. DURING A HOLIDAY WEEK, IF ONE OF THE HOLIDAYS LISTED FALLS PRIOR TO OR ON THE DAY OF YOUR SCHEDULED PICK-UP YOUR GARBAGE WILL BE PICKED UP ONE DAY LATER.
6. WE DON'T CHARGE A DEPOSIT BUT DO REQUIRE \$42 FOR 3 MONTHS SERVICE UPON ENROLLMENT. THERE AFTER WE BILL MONTHLY--\$14.00 OR YOU CAN PAY IN ADVANCE FOR THE QUARTER \$42.00; BI-YEARLY \$84; OR BY THE YEAR \$168.00.
PLEASE NOTIFY US OF CHANGES IN YOUR BILLING ADDRESS, PHONE #, ETC.

7. **IT IS VERY IMPORTANT THAT YOU NOTIFY US IF YOU PLAN TO MOVE SO WE CAN TRANSFER SERVICE OR DISCONTINUE SERVICE & STOP BILLING. IF YOU RELOCATE YOU MUST BRING YOUR CAN BACK TO THE GENEVA COUNTY COURTHOUSE AND MAKE SURE CAN IS CLEAN WHEN RETURNED.**

If your account is 90 days past due, this is **FAILURE TO COMPLY** with the Solid Waste Collection and Disposal Law, and will necessitate legal action as provided by the law, including charging the person in violation with a criminal misdemeanor.
